## General Information about classes

**Beginner 1** –This class introduces dogs and their handlers to the Sport of Agility. Our Beginner Class teaches the dog and handler how to perform all obstacles with safety and work short sequences. Whether your goal is to compete in agility trials or to just have fun with your dog this class will help you build a firm foundation. Dogs must be at least 6 months of age. Exceptions will be made if handler talks with instructors before signing up.

**Beginner 2** – This class is for dogs that have completed Beginner 1 or the equivalent. Dogs and handlers will practice longer sequences and learn basic handling skills. Dogs must be at least 6 months of age. Dogs will not move out of this class until instructors feel they are ready.

**Beginner 3** – This class is for dogs that have completed Beginner 2 or the equivalent. Dogs and handlers will practice longer sequences and learn basic handling skills. Dogs must be at least 6 months of age

**Intermediate** - For dogs who have completed Beginner classes and have not taken Intermediate or who cannot do all equipment at full height. You will practice maneuvers to help you prepare to compete in the Novice level of agility and familiarize you with ring etiquette as well as prepare you for Competition **Dogs need to be able to work off lead and should be over one year old.**

**Competition Class** - For dogs and handlers who have completed the Intermediate class and can do all equipment at full height with no hesitation including jumps and the dog **must be** at least one and a half years old and be able to work off lead and be under control. This class will continue what you have learned in Intermediate and continue to prepare you to compete in all levels of agility.

- ◆ **ALL MONEY MUST BE RECEIVED BY EXCELLENCE IN MOTION 1 WEEK BEFORE CLASSES START TO ENSURE YOU A SLOT**
- ◆ Classes are held outdoors on the grass. Please dress appropriately. Each class is 1 hour long
- ◆ Please bring buckle collar, dog toys, dog treats, 6-foot leather leash, clean-up baggies, water, and a bowl to class.
- ◆ All Classes cost \$85 for all six classes. Handlers who are enrolling more than one dog may take a 10% discount off of their total fees. Please subtract when sending in your check
- ◆ Classes are limited to 8 dogs per class. There is a minimum of 4 dogs to have the class.
- ◆ Directions are included to the training facility at Bark Central.
- ◆ During the season Bark Central will be offering Free Practices for students enrolled in classes. Flyers will be distributed at classes.
- ◆ Drop ins are not allowed for Beginner 1, all other classes if space allows. The cost is \$18 per class.
- ◆ In case of inclement weather call 314-703-5119 for info on if classes will be held. Classes will be canceled no earlier than 1 hour before the first class is scheduled to start for the day.

From Highway 40 and Highway 94 go North on 94 towards St. Charles. Go approximately 1 mile to O'Fallon Road. Make a left on O'Fallon Road. Go approximately 1/2 mile to Ozark Way. Make a left on Ozark Way. Follow to end. Bark Central will be on your right.

From Highway 70 and 94 go South on 94 to O'Fallon Road. Make a right on O'Fallon Road. Go approximately 1/2 mile to Ozark Way. Make a left on Ozark Way. Follow to end. Bark Central will be on your right. Please go down the second gravel driveway and go all the way to the back behind the kennels
